# **Privacy Policy**

## **Our Commitment to Privacy**

This privacy policy was last updated on May 1, 2024. Please read carefully.

Thank you for visiting www.sharegoodenergy.com. Our Privacy Policy has been developed as an extension of our commitment to combine quality products and services with integrity in dealing with users. Your privacy is very important to us at the Good Energy™ Co., and we are committed to protecting and safeguarding your personal information. This Privacy Policy describes how the Good Energy Co. ("we," "us," and "our") uses and protects your personal information collected through our websites, applications, or other forms of electronic communications (collectively the "Good Energy Co. sites").

This Privacy Policy will provide information about how we process your information, with whom we share that information (if at all), and how to contact us if you have questions. By accessing or using any part of the Good Energy Co. sites or services, you agree to the collection and use of your personal information according to the terms set forth in this Privacy Policy.

# **How We Gather & Use Information**

Each time you visit the Good Energy Co. sites, our system automatically collects data and information from your computer system. In particular, we collect the following data from you:

- Browser type
- Operating system
- Internet service provider
- Internet Protocol (IP) address
- Date and time of your visit to our sites
- Information about the website from which your system comes to our website
- Information about the website accessed by your computer system through our website

This data is stored in the log files of our system, separate from other personal information held by the Good Energy Cp. We store log files to ensure the functionality and optimization of the sites and the security of our information technology systems. We do not evaluate your log files for marketing purposes, with the exception of the information collected from your browser settings. This includes checking the language setting in your browser to display the appropriate language version of the Good Energy Co. sites. When this information is no longer required for the functionality of our sites, we delete or anonymize your personal log file information, so attribution to you is no longer possible.

## **Creating a Good Energy Co. Account**

When placing an order through the Good Energy Co. sites, you have the opportunity to register as a Brand Partner, Affiliate or Customer and create a user profile also known as a user account. We may process the following data from you during registration:

- Full name
- Legal entity
- Address
- Email address
- Phone number

- Payment information/ bank account information
- Tax ID number (Brand Partners only)
- Age/date of birth
- Password
- Personal Identification Number (PIN)
- The indication of whether a registered Brand Partner asked you to register as a Brand Partner, Affiliate or Customer (If so, we ask for that Brand Partner's Sponsor ID and/or Enroller ID.)

Alter you have entered your details in the registration form, the Good Energy Co. creates a user account for you and provides you with an ID. We process this registration data to facilitate, alter, and form the contractual relationship between you and the Good Energy Co. and for billing and related services.

Once your account has been created, we may continue to collect additional information about your relationship with the Good Energy Co. including:

- Start/end date
- Gender
- Purchasing and order history with the Good Energy Co.
- Photo identification/drivers' license number
- Account notes
- Signed contractual agreements
- Cart history
- Business Distribution channels (Support Team [also known as ""upline"] and Business Organization [also known as "downline"])
- Commissions and bonuses
- Performance rating
- Brand Partner status and Rank
- Recognition level
- Brand Partner's marketing communications and product claims
- Disciplinary action
- Participation in events and campaigns

## Text Message Campaigns

If you so elect, you may provide your mobile phone number to the Good Energy Co. By submitting your mobile phone number, you consent to receive text message alerts from the Good Energy Co. containing product, service, and event information, product tips or promotions that may be sent using automated dialing systems ("Text Messages"). Your consent to receive Text Messages is not otherwise required to purchase any goods or services from us. You may not consent to receive Text Messages on behalf of someone else or provide someone else's phone number. You agree to enter into, sign, and receive your consent to receive Text Messages electronically.

Text Messages are distributed via third-party mobile network providers and, therefore, we cannot control certain factors relating to message delivery or guarantee availability or performance of this service, including liability for transmission delays or message failures. ## Communications with Good Energy Co.

If you send us an email communication, we may collect the following personal information from you:

- Email address

We gather this information to facilitate the conversation you started with us, to prevent the misuse of our email services, and to protect the security of our information technology systems.

We also offer a Live Chat service on the Good Energy Co. websites, which allows you to contact Good Energy Co.'s Customer Support representatives. Our chat service is a web-based live customer interaction service operated by a third party, which provides a range of high-performance features, support, and communication tools and Application Programming Interfaces (APIs), and enables service employees to reach and assist visitors to the Good Energy Co. sites. Information you provide to the third party forwards directly to our Customer Support representatives. Such information includes:

- Full name
- IP address and/or device identifier
- Video
- Operating system
- Session duration
- Content of communication
- Language settings
- Geolocation-based data

- Other diagnostic data

# **Other Uses of Your Personal Information**

In addition to the specific uses described above, we may use your personal information for a variety of other purposes to:

- Provide you with products and services
- Process payments and fulfill orders
- Calculate and process discounts, earnings, and bonuses
- Determine and track Brand Partner status and Rank recognition levels
- Provide you with promotional information, surveys, questionnaires, and other marketing materials
- Communicate about, and administer participation in, special events, recognition programs, promotions, offers surveys, focus groups, and market research
- Support the business operations of our Brand Partners, Affiliates, and Customers
- Evaluate, develop, manage, and improve our products, services, and other business operations
- Maintain the safety and security of our products and services and prevent any misuse or false advertising
- Protect against, identify, and prevent fraud and other criminal activity, claims and other legal liabilities
- Ensure compliance with applicable law and Good Energy Co. policies, procedures, and agreements, including this Privacy Policy
- Communicate with you about your account or transactions, changes to our policies, and other administrative matters
- Help those you enroll designate you as their Enroller and/or Sponsor by displaying your information in a look-up directory.

## Who We Share Information With

Good Energy Co. does not sell your personal information to any third parties. However, we may disclose personally identifiable information to our subsidiaries, affiliates, external service providers, and other third-party processors to perform data processing services on our behalf. In doing so, we adhere to applicable national and international data protection regulations. We may also disclose personal information to a third party as required by law or to provide and manage our products and services.

If you are a Brand Partner or Affiliate, we may also share your personal information with your Support Team and Business Organization for the purpose of administering sales, distributing products, and providing reports of your activities to other Brand Partners. We may also share your name and photo to those who are looking up the individual who enrolled them so that they can designate their Enroller and/or Sponsor.

## **Google Maps**

Some of Good Energy Co.'s sites utilize Google Maps API, a map service operated by Google Inc. ("Google"). This allows us to show you interactive maps directly on the Good Energy Co. sites and provides you with convenient use of the map feature. By visiting the Good Energy Co. sites through which the map services are offered, Google receives the information that you have accessed the corresponding sub-page of our Good Energy Co. websites. In addition, the following personal information is communicated to Google:

- IP address
- Date and time of the request
- Time zone
- Content of the request
- Access status/HTTP status code
- Each transferred amount of data
- Website from which the request comes
- Browser type and version
- Operating system
- Language preferences

When you're logged in to Google, your data will be assigned directly to your Google account. If you do not wish to be associated with any profile on Google, you must log out before activating the button. Google stores your data as usage profiles and uses them for purposes of advertising, market research, and/or tailor-made website design. Such evaluation will be carried out, in particular (even for non-logged in users), to provide on-demand advertising and to inform other users of the social network about your activities on our Good Energy Co. sites. You can deactivate the service of Google Maps and prevent the data transfer to Google by disabling JavaScript in your browser. # Cookies

When using the Good Energy Co. sites, various types of cookies are used and stored on your computer. Cookies are small text files stored on your device that tell websites who you are. Through the settings in your browser, you can elect to disable, limit, or delete cookies. However, we cannot accomplish many of the basic functions needed to create and process an order on our sites without cookies. For this reason, we recommend you keep cookies activated. We have broken up our cookies into categories to help you understand what they do.

- 1. Strictly Necessary Cookies: These cookies are necessary for the website to function and cannot be switched off in our systems. They are usually only set in response to actions made by you which amount to a request for services, such as setting your privacy preferences, logging in or filling in forms. You can set your browser to block or alert you about these cookies, but some parts of the site will not then work. These cookies do not store any personally identifiable information.
- 2. Performance Cookies: These cookies allow us to count visits and traffic sources so we can measure and improve the performance of our site. They help us to know which pages are the most and least popular and see how visitors move around the site. All information these cookies collect is aggregated and therefore anonymous. If you do not allow these cookies, we will not know when you have visited our site and will not be able to monitor its performance.
- 3. Functional Cookies: These cookies enable the website to provide enhanced functionality and personalization. They may be set by us or by third-party providers whose services we have added to our pages. If you do not allow these cookies, then some or all of these services may not function properly. These cookies enable the website to provide enhanced functionality and personalization. They may be set by us or by third party providers whose services we have added to our pages. If you do not allow to provide enhanced functionality and personalization. They may be set by us or by third party providers whose services we have added to our pages. If you do not allow these cookies, then some or all of these services may not function properly.
- 4. Targeting Cookies: These cookies may be set through our site by our advertising partners.
